Mon May 5 - LC BOS Public Input meeting - request support for "Climate Communities" initiative being proposed by Sup McGimsey. Khalial Withen briefly described this initiative and relayed Sup McGimsey's urgent request for vocal support for it at Monday's public comment.

Wed May 7 - LC Energy Efficiency Committee (E2C) Listening Session - request that we sign up to provide concrete ideas and strategies for what the E2C can be doing to increase Energy Efficiency in Loudoun

Julie Metz wants to invite Sustainable Loudoun to again participate in the Lucketts Fair Green Pavilion tent this coming August 23/24. Tony committed to coordinating our effort to be there and encouraged everyone to take a time slot to participate. Gina Faber volunteered to coordinate Sustainable Loudoun's participation in the Bluemont Fair, Sept 13/14. We are hoping to draw upon the same resources for both events.

Sierra Club

Several members associated with Sierra Club, VA and Great Falls chapter described their organization, the advantages of membership, and the prospect of LCCSS somehow becoming aligned with Sierra Club to our mutual benefit.

Among the advantages Sierra Club could offer LCCSS:
